(130) (Formerly offered as NRME 1235.) Second semester. Three credits. Barclay
Overview of resource use history and conservation policy development from prehistoric to present times as seen through major historic and cultural continuities, dominance of human value concepts, major religious perceptions vis a vis colonialism/native peoples context, and embodiment in U.S. governance documents. Emergence of the 20th century conservation movement is examined within the context of current and future environmental issues. CA 1.
