College of Liberal Arts & Sciences Committee on Curricula & Courses Minutes of the 13 November 2001 Meeting (FINAL) 3:30pm in Room 162, the Dodd Center

- **1. Preliminaries:** a. Chair Rob Henning called the meeting to order at 3:35pm.
- b. Manning was appointed secretary pro tem.
- c. The minutes of the 30 October meeting were acknowledged as having been approved by email vote on 7 November.
- **2. Old Business**: a. Discussion of the continuing matter of GER reform now before the Senate. Henning reported upon last week's meeting of the Organizing Committee, including the possible introduction, by Senator Ernie Zirakzadeh, of an amendment to the CLAS proposal to separate writing requirements from GER courses. Prof. Zirakzadeh's amendment would restore some form of requirement that a writing-intensive course be completed in the student's major, and within the final 60 credits presented for the degree.
- b. **2001-132** Add WS 371, Genders and Sexualities (Prof M. Breen), tabled earlier. Tabled again for further work on the proposal. The committee noted the lack of required information about approvals received, about its effect upon other campuses, and about its effect upon other departments (it was noted that the proposed instructor holds her appointment in English at the Avery Point Campus, but that no affirmation could be made about approval from either.). The proposal will be returned to the committee at a later date.
- c. 2001-175 Catalog change concerning GPA required in major (Dean Makowsky). Copy to be changed to read: '... have an overall grade point average of at least 2.0 and a grade point average of at least 2.0 in the courses presented in satisfaction of major requirements.' This acknowledges that some CLAS major programs require more than 24 credits in the major field, and that the rule's intent is to apply a uniform standard to all required courses in all majors. Approved.

- a. Special Topics courses (both spring 2002)

- 1. **2001-176**: Econ 298 Urban Policy and Development, announced as approved by the Chair.
- 2. **2001-177**: Anthropology 298 Ethnobotany: Plants and People. Reported to the committee for review of the proposed instructor's CV. Approved by vote.
- **b.** Curriculum Proposals (Note: Although the following proposals are given here in numerical sequence for ease of reference, certain discussions were in fact held out of sequence by agreement of the committee.)
- **2001-178 through 2001-186 (inclusive)**. These items, eight concerning graduate courses in Geography and one concerning a change to degree requirements in Geography, were tabled until the meeting of 11 December at the department's request.

2001-189A (Note modified number to correct mislabeling of the proposal) Add WS 2xx Women and Body Art. Approved, subject to a) improvement of catalog copy, to be approved by the chair, and b) re-examination of the 'open to sophomores' provision, which will redirect the proposal to the Senate should the department wish to retain it.

CATALOGUE COPY:

Women and Body Art. WS 2xx. Either semester. Three credits.

Women's use of body art to express aspects of gender identity and interpretation of body art from a variety of cultures. "Body art" encompasses cosmetics, painting, hair styling, tattoo, scarification, clothing, ornaments, plastic surgery and exercise.

2001-190 Add WS 3xx Feminist Theories of Globalization and Resistance. Approved, subject to revision of title and catalog copy, as approved by the Chair.

Abbreviated Title: Globaliz and Resist

CATALOGUE COPY: WS 3xx, Feminist Theories of Globalization and Resistance Either semester, alternate years. Three credits.

Interdisciplinary examination of relationship among feminist theorizing, women's movements, women's activism, and global political and economic restructuring. Explores links among local resistance, immigration, cultural citizenship, international politics, neoliberal discourse, and global economic restructuring.

2001-191 Cross-list AASI 268 with History 268. Japanese Americans and World War II. Approved.

2001-210 Add a new major, **American Studies**. After lengthy discussion the Committee tabled this proposal pending its further development by the proposing group. Much comment was offered about a) the proposal's inclusion within its scope, despite the makeup of the sponsoring committee and its published materials, of the entire American hemisphere, and b) the uncertain division of disciplinary competence between the proposed field and that of Latin American Studies.
