# Motion to amend committee action of 11 October 2006, Policy concerning offering & staffing of cross-listed courses (revision required):

**Present policy text:** a. In scheduling courses cross-listed with one or more CLAS programs, the course should normally be offered under all catalog subject headings for the course and, whenever possible, in consultation with the Directors or Heads of all subject areas under which the course is listed in the catalog.

b. Instructors for cross-listed courses will be assigned only with the prior approval of the Heads or Directors of all subject areas under which the course is listed in the catalog. Once an instructor is on a joint "approved" list, he/she may be hired subsequently without seeking further approval. (C&C Committee minutes, 11 October 2005).

Proposed policy text (changes to paragraph a only; paragraph b to stand as is):

a. In scheduling courses cross-listed with one or more CLAS programs, the course must be offered under all catalog subject headings for the course and in consultation with the Directors or Heads of all subject areas under which the course is listed in the catalog. Exceptions to this policy may be granted in exceptional circumstances by the Dean of CLA&S. **Approved unanimously**

## 2006-90 Proposal to Change the URBN Major: APPROVED Urban and Community Studies

The undergraduate major in Urban and Community Studies is an interdisciplinary program in the College of Liberal Arts and Sciences with a focus on educating citizens on the multiple dimensions of urban and community life and preparing students for careers in public and community service as well as graduate study in social work, public administration, law, public health, or other related areas.

The major has three parts. First, students receive a broad education in the study of cities, suburbs, neighborhoods and communities through core courses in three fields drawn from Economics, Geography, History, Political Science, Public Policy, Sociology, and <u>URBN 248</u>. Second, students acquire a solid foundation in analytical techniques such as statistical analysis, survey research, geographic information systems, qualitative methods, or archival research. Finally, students take three additional electives in order to broaden their academic training or to develop a deeper specialization in selected areas.

In order to assure a breadth of experience, students are encouraged to take courses which include content in each of the following areas: change over time, structural and spatial dimensions, diversity, power and decision-making, and political and social processes. One unique option for students is to enroll in the 15 credit Urban Semester Program, which provides major credit for two courses <a href="INTD 211">INTD 211</a> and <a href="212">212</a>.

Students interested in pursuing a program in Urban and Community Studies are advised to complete 100-level courses in the social sciences which are prerequisites for courses in Urban and Community Studies. These include, but are not limited to, <u>GEOG/URBN 130</u>, <u>ECON 112</u>, <u>POLS 173</u>, <u>SOCI 107</u>, <u>SOCI 115</u>, and <u>STAT 100/110</u>. They should also plan on enrolling in <u>URBN 230</u>, which is open to sophomores, as soon as possible.

Either semester. Three credits. Prerequisite: CHEM 124Q. Two class periods and one 3-hour laboratory period. Open by consent of instructor for only 1 credit to students who have passed CHEM 127Q, 129Q, or 137Q. Not open to students who have passed CHEM 128Q, 130Q, or 138Q.

GEOG 301. Fundamentals of Geographic Information Science 3 credits. Lecture.

Introduction to the theory and methods for representing, acquiring, storing, manipulating, displaying, and analyzing geographic features in relation to the surface of the earth.

#### 2006 - 120 Proposal to Senate to add MATH 108QC to GE Content Area 3: APPROVED

Math 108QC. Mathematical Modeling in the Environment. Either semester. Three credits. Recommended preparation: MATH 101, 104 or the equivalent. A solid background and good performance in high school algebra are highly recommended.

An interdisciplinary approach to environmental issues, such as: ground water contamination, air pollution, and hazardous materials handling. Emphasis on mathematical models, social and ethical implications, and physical and chemical principles. Includes a spreadsheet program for water and air pollution data; a computer modeling package to analyze hazardous materials emergencies; creative use of the internet and field research. CA3.

#### 2006 - 121 Proposal to Change HDFS 296H -- add W: APPROVED

HDFS 296HW Honors Thesis. Either semester. Three to six credits. Hours by arrangement. Prerequisite: Open only with consent of instructor to students in the Honors Program. Student must have a thesis advisor and have an approved thesis topic.

Individual study with student's honors thesis supervisor for the purpose of writing the honors thesis.

Contentious topics in current media effects research, and their theoretical implications. Topics include, but are not limited to, sexual content on television, pornography, alcohol on television, video games, and media impact on body image.
