Meeting called to order at 1:03pm.

1. Minutes of the February 12, 2013 meeting

3. Subcommittee Reports

<u>CA1</u>

The committee recommends approval of the following revised course proposal as an intersession course:

LAMS/HIST 3635 Mexico in 19th and 20th Century

The motion carried unanimously.

CA2

The committee recommends approval of the following new course proposal:

ANTH 1010 Global Climate Change and Human Societies

Discussion:

- In a discussion of the course, both CA2 and CA3 committee members weighed in on the proposal
- One subcommittee member noted some typos and grammatical errors and questioned what the subcommittee's
 responsibility was with regards to technical issues. It was noted that the Senate C&CC often handles the wordsmithing and
 grammatical correction of proposals.
- Some technical and syllabus-related issues with the proposal lead to a discussion of what the actual responsibilities of the subcommittees are. Some new subcommittee members asked for clarification of their roles
- It was expressed that the subcommittees' primary responsibility is to determine whether the course meets the content area criteria for their group. Some subcommittees have sometimes sent proposals back for instructors to make corrections, but it was noted that feedback/questions to instructor should be couched in CA criteria, not in pedagogy
- One member felt the syllabus and overall course proposal seemed inadequate, citing the proposed 300-student enrollment with a term paper, and a 64-topic "laundry list" syllabus that did not explain how the topics would be addressed throughout the course
- It was clarified that GEOC and subcommittees were not charged with evaluating the syllabi for courses and that asking for too many details could be conceived as "micromanaging" the course
- Overall it was determined that issues with the syllabus and technicalities with the proposal could be handled at the next level and that the proposal succeeded in meeting its Content Area criteria

4. Reports and Discussion

Murphy Sewall's meeting with V. Provost Reis – "DFW" Gen Ed courses

- Two items on the agenda were 1. The department budget, including assessment of 1-credit W's in Fall 2013, and making Provost's Competition bi-annual. Both were approved. The only question around the budget was a discussion of the extra funds allotted to the GEOC Chair for serving as the head of the committee, which is not the case on many other committees
- V. Provost Reis ask that the GEOC focus especially on DFW courses for the next Provost's Competition (courses in which 40% or more of students take a D, F or W); the goal would be to improve the quality of these courses and create more consistency across sections.

Discussion of CA1 Guidelines

- Francoise Dussart requested that the CA1 subcommittee be allowed to edit the wording for criteria in CA1; the GEOC
 expressed support for this with the understanding that the revised wording would need to be proposed to the Senate
 C&CC and then the Senate for approval
- The CA1 subcommittee noted that changes would not be dramatic, but would include wordsmithing as well as language that would better explain how the various criteria connect with one another
- Francoise Dussart will present a draft of the edits for the next GEOC meeting
- CA3 expressed an interest in possibly refurbishing their criteria as well

Clarification of a question asked at a previous meeting

• The new Environmental Studies program will be a BA under CLAS, as opposed to the Environmental Science major, which is a BS
