a. This course will require students to complete the writing process in a systematic, logical manner. This process will be integrated into the content covered in ANSC 3316, Endocrinology of Farm Animals by having students investigate a topic of interest which is directly related to the information covered in the course.

b. The course will require submitting 15 pages of reviewed and revised material focusing on a subject of the student\\\\'s choice (related to class material). The development of the paper will occur in stages throughout the semester, starting with choosing and justifying a topic, proceeding through an outline stage and first submission stage, and culminating with the submission of the final paper. Peer review, as well as instructor review, will be used throughout the process. Failure to pass this course will result in failure to pass the co-requisite course (ANSC 33XX, Endocrinology of Farm Animals).

Students will be required to submit a final 15 page literature review which will be peer reviewed and reviewed by the instructor once prior to final submission. While this course will be graded separately from the co-requisite course, failure to pass this course will result in failure of the co-requisite course as well. Instruction will be provided in a variety of ways, including formal instruction, individual conferences and written commentary. Revision of the initial outline of the review will be allowed based on comments from the instructor to improve organization, amount of material covered, etc. A draft of the review paper will be edited by the instructor and will be peer reviewed for content as well. Students will have an opportunity to respond to these reviews in writing and through the revision of the initial draft.

The syllabus will contain the \\\"F clause\\\" stating that failure to pass the \\\"W\\\" component will result in failure to pass the co-requisite course.

Writing Assignment

The course requires a final submission of a **15-page (double-spaced; 12 pt font with 1" margins all around)** review paper (**with at least 10 peer-reviewed articles; literature cited page does not count towards the 10 pages of written material**) on a subject of your choice. The topic must be related to the material in class. That is, the relationship between the topic and the course must be justified.

The goal is for the student to investigate an area of growth physiology, metabolism, or endocrinology that is of personal interest. That is, each student will research and write about a topic that is related to the class that the student wants to study in greater depth.

The development of the paper will occur in several steps:

- Justification of topic and its relationship to the class (must be approved by instructor) 1 to 2 paragraphs that identifies topic, relevance to class and interest to student
- Outline of paper with 5 peer reviewed references, including a short summary of each reference The outline should have detail on the topics to be included in the paper. The summaries of each peer-reviewed article should include a summary of the article and how it will be used in the paper
- 3. First Submission 15-page (double-spaced; 12 pt font with 1" margins all around) review paper (with at least 10 peer-reviewed articles; literature cited page does not count towards the 15 pages of written material)
- 4. Revision of first submission and submission of final paper 15-page (double-spaced; 12 pt font with 1" margins all around) review paper (with at least 10 peer-reviewed articles; literature cited page does not count towards the 15 pages of written material)
