37. **RATIONALE** FOR ACTION REQUESTED

In previous years, a course entitled Introduction to Music Education was offered for 02 credits to students in the fall semester of their third year as music majors (course number Music 3571, Seminar in Music Education: Introduction to Music Education). With the recent revision of the music edcuation curriculum as part of Neag's IB/M program, students now apply for formal admission to Music Education in their second year. Accordingly, this course is specifically designed for freshmen interested in Music Education to introduce them to the practice and art of teaching music in a variety of school settings, and to help them prepare for successful application to the Music Education program at UConn; hence the change of course number from 3000 to 1000-level. The course is limited to music majors with Music Education as their prospective degree program.
