## 2.1 UNIV 1985: Special Topics: The Holster First Year Project

Overview

• J. Deans explained the purpose of the course and noted that the design was changed somewhat in response to the needs of Biological Sciences students who take it; about six to eight students are selected for the course; any first year student can apply

- One UICC member questioned where the "Holster" part of the course came from; J. Deans
  explained that Robert Holster is the name of the benefactor who endowed the fund for the

Motion to approve the course UNIV 1985 by T. Long. Motion seconded by E. Donkor. The motion was approved unanimously.

# 3.2. UICC Policy Manual

#### Review

• At the request of H. Freake, K. Piantek reviewed all the minutes of past UICC meetings to pull policy information and draft a manual based on current UICC practices.

## Discussion:

- One member suggested that a description of the committee based on the website be added to section 1.1 of the document
- L. Gramling questioned what the word "accredit" meant in the Senate charge to the UICC in section 1.1.
- T. Long asked if that meant that anything approved must go on to Senate C&C; H. Freake
  answered that INTD courses get approved but then pass back to schools and colleges who
  accredit; UNIVs go on to the Senate C&C and the Senate
- Suggestions were made for content under 2.3. and 2.4.
- H. Freake indicated that the language on co-sponsorship (section 3.1.1) has been questioned recently based on discussion with Stanton Wolfe regarding the creation of Disability Studies courses; S. Wolfe wanted to know if he needed one or two co-sponsors for his course proposed INTD course— the language in section 2 under "standing" is somewhat contradictory. H. Freake asked the committee if they should correct the language in this section to be clearer.
- M. Buck indicated that catalog language would need to be changed if the UICC decides that the policy needs adjustment
- L. Gramling suggested that the language was drafted the way it was because there are some academic departments that have two prefixes, so those don't count as interdepartmental
- H. Freake proposed the insertion of "or units" at the end of the sentence, "UICC expects that an interdepartmental course proposal will normally be co-sponsored by at least two academic departments" in section 3.1.2.c.

# The motion to add "or units" was moved by T. Long, seconded by E. Donkor and passed unanimously by the UICC

- Minor adjustments to section 3.1.2 on the adoption INTD of courses were suggested
- Minor adjustments to the "light touch" language of section 3.2. were suggested
- Minor adjustments to the Study Abroad language of section 4.1. were suggested
- In clarifying the section on NSE courses (section 4.2), H. Freake asked the UICC how they would like to handle these courses. The consensus was that they should be handled like Study Abroad courses.
- Because the UICC reports to Provost, H. Freake suggested that the committee should be giving UNIV credit instead of INTD for Study Abroad courses
- The committee asked about how many courses this generally applied to; K. Piantek will bring a report of Study Abroad courses for the next meeting.
- L. Gramling noted that the courses were not by definition INTD, but also not by definition UNIV either
- H. Freake reiterated the feeling from previous meetings that this is ultimately Study Abroad's
  issue; J. Lowe asked about nudging the Provost's Office to talk to Study Abroad about this
  again, and H. Freake agreed that this would be done.
- H. Freake informed the committee that the language for the grade appeals section 4.5. had been slightly revised from the featured draft on 4/5/13; the committee was provided with a

print-out of the most updated language that would be substituted into the manual document in this section.

# **5.1** Short Study Abroad courses in Learning Communities
